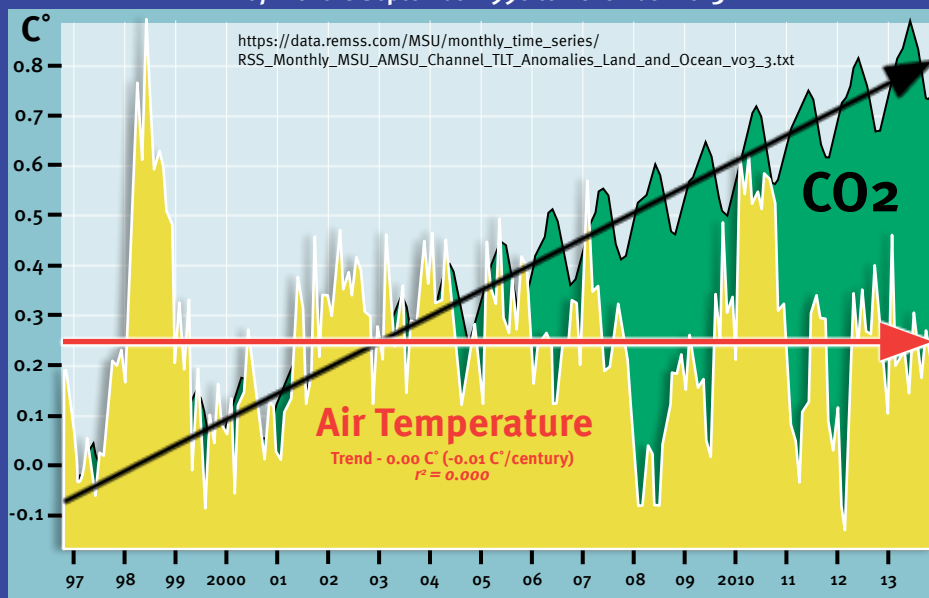

## CARBON DIOXIDE HAS ZERO EFFECT ON TEMPERATURES

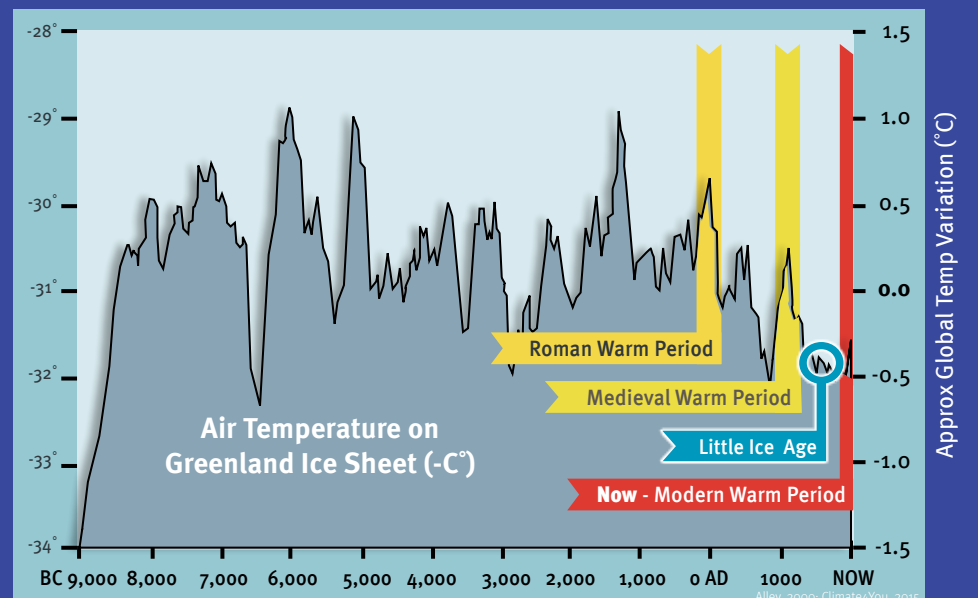
Earth's recent surface temperature v CO2 levels

# All hail the... globalist

## King Charles is putting politics back on the royal throne

**WE have a globalist king. That is now being said more and more, and the point does need to get through to the whole population.**

But Charles is no mere supporter of globalisation; he is right at the centre of the globalist agenda.

Television presenter Neil Oliver made a point in a video from his home in Edinburgh that the king should keep out of politics, but the new king is deeply involved in it. He has been actively promoting the idea of man-made global warming, which is a highly contentious political issue, as, too, is the issue of the pandemic.

I expected Neil Oliver to be taken off for the coronation, because the breakfast presenters on GB News, as well as many of the evening presenters, seemed to belong to the 'Isn't it marvellous' brigade when it comes to the royal family.

They seem to be appealing to the libertarian right on just three issues - Brexit, man-made global warming, and the fake pandemic - but supportive of the establishment on everything else. Neil Oliver seems to be out on a limb in warning of the dangers of a political king.

But the Neil Oliver show did go ahead. As before, I agreed with practically everything he said, but this time there were, for me, two contentious issues: God and a hereditary monarchy.

I think religion plays an important part in the cohesion of any nation or ethnic group, but only if people don't believe in it too deeply. From the moment they owe allegiance to religious leaders, the path to tyranny is set. The argument in

favour of a hereditary monarchy is simply that otherwise, we open the door for politicians to take over. But what do we actually have now?

Charles III must be one of the most experienced and established politicians in living memory, and he has very powerful backers.

Neil Oliver talks of a 'constitutional monarchy'. I've never understood that term, because it implies that other monarchies aren't constitutional.

Certain principles are generally accepted to be incorporated in the British Constitution, but what exactly constitutes the British Constitution? What matters is what those in government think

the constitution is, and that is defined in a Cabinet Office document.

Even the number of documents which constitute the constitution is not specified. I can say that if I were to try to open a bank account for a membership association on the basis of such a constitution, it would almost certainly be rejected.

The Supreme Court claimed in its ruling on the Prorogation of Parliament case that an advantage to the present form of the constitution is its flexibility. Flexible for them, no doubt, but not for us, the plebs, so it doesn't even fulfill the basic role of protecting the ordinary guys against excessive powers.

What people generally understand is that we have a titular monarchy, with no real power. But that is simply not the case. All international treaties are ratified under the Royal Prerogative. The two chambers have no formal say. That gives enormous powers, and the globalist agenda relies on such international treaties.

I remember Lord Hailsham saying, in a BBC lecture in 1976, that we have an elective dictatorship. Only now do I see the full impact of those words. But at the moment, it's not even elective: if the Prime Minister doesn't follow the wishes of the establishment, presumably communicated through the Cabinet Office, then they go.

Rishi Sunak wasn't elected, but

stepped in when 'behind-the-scenes economic forces' forced Liz Truss to resign. Boris Johnson was forced to resign by the Partygate scandal following a report by Sue Gray of the Cabinet Office.

According to that report, a major player in Partygate was the Cabinet Office. On one occasion, they all exited Downing Street along a corridor into the Cabinet Office building round the corner in Whitehall. One picture in the report showed Rishi Sunak at one event talking to Boris Johnson. So why did Boris Johnson have to resign, to be ultimately replaced by Rishi Sunak, with the Cabinet Office still in office?

Our democracy is fickle. I have over the years struggled to understand how we can have become so brainwashed as to believe that we are the 'mother of all parliaments'. We have three elements to our parliament: two chambers and the Crown in Parliament. The latter involves draconian powers.

I came to the conclusion long ago that the English must be the most brainwashed people on Earth. We believe what we are told by the authorities, even if we believe the opposite to be true as well. Orwell called it 'doublethink'.

I was particularly intrigued to read what Prince Harry wrote about in his book *Spare*. Speaking about an interview with a journalist, he said: "I told the reporter that I thought the British press was crap, particularly with regard to my brother and sister-in-law. 'They deserve to have their baby in peace,' I said. Everyone's guilty for buying the newspapers. But hopefully no-one actually believes what's in them. But of course they did. People did believe, and that was the whole problem."

# The state we're in – MPs answer questions

**WHAT** do our parliamentary representatives really think about climate change, covid-19, mass immigration and transgenderism? In the April edition of *The Light*, I presented ten questions for readers to send to their MP. Fifteen sets of answers were received, including from Prime Minister Rishi Sunak. The respondents comprised ten Conservative, one SNP and four Labour MPs, with only one female respondent. The answers are a revealing guide to the state we are in.

## 1. Do you believe that there is a climate crisis?

MPs were unequivocal on anthropogenic climate change. Sunak emphasised the urgency: 'The UN's International Panel on Climate Change has concluded that the world is warming faster than anticipated, the effects of which are being seen in every single region of our world. Immediate action is needed to limit warming, heatwaves, heavy precipitation, droughts, and loss of Arctic Sea ice, snow cover and permafrost.'

Rachael Maskell (Labour, York Central) even foresaw famine: 'Across the planet, the failed crops due to the changes in the climate is resulting in parts of our globe becoming uninhabitable.'

*What they didn't say: notably, only one MP mentioned the contentious 'Net Zero'; they talked of carbon targets but not the ultimate aim of total resource control.*

## 2. Do you believe that covid-19 was a deadly pandemic?

According to Sunak, covid-19 'was one of the greatest challenges this country faced since the

Second World War'. This is ironic, given his party's expulsion of Andrew Bridgen for a similar comparison. The SNP respondent replied: 'having lost friends to this deadly disease, my answer is an unequivocal yes'. Bill Wiggin (Conservative, North Herefordshire) wrote: 'I caught covid and was very seriously ill, Boris nearly died, many others were not so lucky'.

*What they didn't say: symptoms and mortality were similar to that of influenza, which magically disappeared for three years.*

## 3. Do you believe that lockdown was necessary?

Two years after schools, churches and pubs were forced to close, there is little remorse from MPs, although John Redwood (Conservative, Wokingham) had voted against the draconian legislation. All others thought that lockdown saved lives.

Mark Eastwood (Conservative, Dewsbury) referred to the modelling prediction of Neil

Ferguson at Imperial College that unless we followed China's approach, hundreds of millions would die, while the NHS would have been 'overwhelmed many times over'.

Some MPs suggested that lessons would be learned from the covid-19 inquiry (a likely whitewash), but according to Huw Merriman (Conservative, Bexhill & Battle), 'until an effective vaccine was developed and rolled out, unprecedented public health measures were required'. Sunak claimed to have mitigated its economic impact as Chancellor of the Exchequer.

*What they didn't say: no MP mentioned the International Health Regulations, which could impose global lockdown.*

## 4. Do you believe that the covid-19 vaccines are safe and effective?

According to George Haworth (Labour, Knowsley), 'given the urgency of the situation, the vaccines were as safe and effective

as could reasonably be expected'. Merriman and other Tory MPs used stock statements: 'I can assure you that the MHRA has followed rigorous procedures to ensure the vaccines meet the high standards needed to be considered both safe and effective... Millions of people have been given a covid-19 vaccine and reports of serious side effects, such as allergic reactions, have been very rare.'

*What they didn't say: the trumpeted 'miracle of science' was an illogical feat as the trials could not compress time: long-term safety and efficacy cannot be known from short-term testing; no MP mentioned the troubling surge in mortality since the rollout.*

## 5. Do you support billions of pounds of military supplies and indirect or direct involvement of our armed forces in the war in Ukraine?

No respondent doubted the cause in Ukraine. Again, Tory MPs such as Mark Pawsey (Rugby) shared the

same text: 'The UK cannot stand idly by whilst Russian troops lay siege to once peaceful European cities, whilst tanks tear through towns and villages and ordnance rains down indiscriminately on homes and hospitals. We have the moral duty to respond to these horrific acts, which are not only an attack on the principles of the UN Charter but also amount to war crimes.'

Sunak concluded that 'Putin must fail – and we must work to ensure he does'. Maskell warned that unless stopped, Putin will rampage over Europe. However, several MPs assured that there is no prospect of British or NATO forces fighting in Ukraine.

*What they didn't say: the UK is a prominent actor in the West's proxy war with Russia, recently sending depleted uranium shells (which went up in radioactive smoke when the Russians struck an ammunition store).*

## 6. Do you regard the tens of thousands of people crossing the English



Channel and entering the country illegally as refugees?

MPs are aware of public unease about the daily arrival of young men crossing the English Channel. On whether these are genuine refugees, Andrew Stephenson (Conservative, Pendle) remarked: ‘No, and by legal definition they are not refugees until any claim they make for asylum has been accepted. It should be noted slightly less than half do apply successfully. I support the Rwanda plan and the Illegal Migration Bill, and welcome the Prime Minister’s plan to stop the boats.’

John Whittingdale (Conservative, Maldon) averred that most of the gatecrashers are ‘economic migrants’ who should be sent back. Sunak accepted that ‘the volume of small boat arrivals is overwhelming our asylum system and diverting resources from those in genuine need’.

Labour MPs were concerned about slow processing of asylum claims, Haworth claiming that ‘over 90% of those who seek asylum are deemed to have satisfied the criteria for refugee status, either on the basis of their initial application or on appeal’. According to

Maskell, ‘the globally unstable world, crop failure and the abuse of human rights, through to modern day slavery and torture is causing some to migrate’.

*What they didn’t say: the number arriving (whether by small boats or by air, ferry or rail routes) is set to surge due to United Nations policy of mass resettlement from poor to rich countries.*

7. Do you believe that it is safe for dozens of undocumented male migrants to be housed in our towns?

Sunak acknowledged that ‘there are currently over 45,000 asylum-seekers living in hotels around the country, at a cost to the taxpayer of more than £6 million a day’.

To accommodate ten thousand of them, disused holiday parks, student halls and military sites are under acquisition, Sunak remarking: ‘this accommodation should be rudimentary and will be designed to protect the local community’.

Merriman, facing uproar over a huge migrant camp in his constituency, tried to allay fears: ‘The Home Office confirmed

that all asylum seekers arriving at Northeye will be screened... Claims for asylum will be viewed negatively should any law-breaking or trouble occur during the applications stage.’

*What they didn’t say: the first priority of government is the safety of its own citizens, but large numbers of young males are being placed in residential areas, potentially endangering women and girls.*

8. Do you support teaching of transgender ideology to our schoolchildren?

Edward Timpson (Eddisbury), in a lengthy text also used by other Tory respondents, explained: ‘It is up to schools, with the support of teachers and parents, to decide the most appropriate and necessary policies to put in place for their pupils...The Department for Education is clear, however, that schools must tackle all forms of discrimination and this includes gender reassignment or sexual orientation.’

Sunak explained that government guidance will ‘support schools both in relation to transgender pupils and those who are

questioning their gender’. He assured parents that they would be involved in any decision about their child.

*What they didn’t say: the state is the arbiter on child’s gender identity, and parents’ views will be overridden, if not criminalised.*

9. If you do not agree with any of the above, what are you doing to oppose such a policy?

This question was a dud, as the MPs were mostly following the narrative.

10. Finally, what is a woman?

Most respondents defined a woman as an adult human female, Whittingdale explaining: ‘The Gender Recognition Act provides a way for people to change their gender, but biological sex allows us to determine the difference between a man and a woman and this is set at birth with a woman having two X chromosomes, and a man an X and a Y’.

Stephen Kinnock (Labour, Aberavon) eschewed such clarity, based on personal experience: ‘Let’s not disparage or fail to

support those who are non-binary in terms of their gender identity. For example one of my two children was born female as Camilla but is now called Milo, and uses the pronouns he / him. Milo is a truly wonderful person, and I love him and am incredibly proud of him.’

Maskell fears undue influence of transgender ideology, asserting that ‘children should be taught to be safe in their identity as a boy or girl’.

*What they didn’t say: the clarity of definition of an ‘adult female’ may be misleading - would a trans woman (biologically male) fit this criterion?*

**To conclude, despite their efforts to justify the prevailing narrative and policies of the political establishment, the MPs showed themselves at odds with many, if not most of their constituents. Although not directly mentioned, parliamentarians are pursuing Agenda 2030, a programme managed above national level behind a façade of democracy.**

# From conservatism to corporatism

**THE culprit which has led to the many crises that have seemingly hit the British people - and other nations in the West - is corporatism.**

It is that combination of right-wing corporate power, socialist totalitarianism and state power which marginalises the true democratic forces in society – individuals, families, communities, personal enterprise, the nation state and parliament itself.

Corporatism arises as the right moves left (as it did in Britain under Major, Cameron and May), and the left moves right (as it did under Blair) and in the past has been the foundation of Nazi and fascist systems of government. Mass immigration is encouraged by ideological leftists and corporations seeking cheaper labour. The woke values of what

some call the ‘liberal’ urban minority manipulate the state from their own corporate institutions in academia, civil service and the media.

Even wars (launched without public consultation of course) are profitable for armament corporations, and politically for grandstanding politicians - who, upon leaving office, suddenly acquire great wealth.

The large corporations have easy access to the savings of the people in the City (where individual and family investors have virtually disappeared), and the state has easy access to the earnings of the people through oppressive taxation.

Corporatist power, unlike market responsibility, is easily manipulated by a few individuals and minority political ideologies – like cancel culture, the racist ‘critical race theory’ and transgender notions.

In 1990, my paper, *Conservatism in Danger*, published in The Bow Group, warned that the Tory party was becoming corporatist, and this would mean their long-term defeat. They later limped to their worst defeat since 1906, and 13 years in opposition followed.

From 2010, another 13 years in government has not corrected this deviation but instead ensconced corporatism in a society which is now on the brink - led by a party similarly positioned!

The journalist Harry Phibbs attended the Bournemouth conference of the recently established Conservative Democratic Organisation. He wisely noted that Bournemouth was a profoundly symbolic venue (for the CDO conference).

Seaside venues were chosen for party conferences when the membership was valued. For several years it alternated between Brighton and Blackpool. There were smart hotels for the

high-ups – but also plenty of cheaper hotels and guest houses to ensure it was affordable for those members on more modest means.

Then it turned into a trade fair, a lobbying fest. Manchester and Birmingham were more suitable, with expensive but characterless hotels for those with corporate expense accounts. Party members were priced out.

Organisationally, members had long been priced out. The Conservative Democratic Organisation seeks to return power to party members and reduce the corporatist power exercised by functionaries at the party centre. Many years ago, a well-known journalist went for an interview at the then Conservative Central Office. Having said she was not sure if she was a Conservative and had some left-wing ideas, the interviewee said: “Oh that is not a barrier to making a career in politics.”

A neat summary of corporatist politics!

Meanwhile, no ceremony is supposed to better encapsulate the spirit of the people in a constitutional monarchy than those invited to a coronation. Those invited to the coronation of Charles III included the Chinese politician responsible for the democracy crackdown in Hong Kong, and a Sinn Fein leader from a prominent IRA family. Not invited was the late Queen’s bridesmaid whose father was murdered by the IRA. Those are the values of corporatism and statism.

The loss of democracy in Britain and the dominant role of collectives of capital and state have arisen not because the people have a loss of votes – but a complete loss of choice. Corporatism has conspired on left, right and centre to make all voters powerless.

# Promoting informed consent

## Mums unite to expose Big Pharma's biggest secret

**IN September 1991, I happened by chance to come across an article entitled, *Vaccination – The Hidden Facts*, featured in the London Evening Standard weekly magazine, ES.**

Prior to reading this, I had always thought, like so many, that vaccination was safe, effective and without question.

Both my young daughters had received the recommended vaccines, which fortunately were very few at that time. However, one was due her MMR that month, and so I read the article with great interest.

Alarm bells went off, and by the time I had finished the article I was thirsty to know more. What was the true cause of the decline in diseases, what were the vaccine ingredients and the potential problems of injecting them into the body?

What number of vaccine injuries and deaths were happening, and why were they rarely talked about? The article asked at the end to, 'send a self-addressed envelope for a suggested reading list', and so I did. This started me on a new understanding of health and disease for the next 32 years.

I was never one for just reading and believing one view, and when the list of suggested book titles arrived, I found myself ordering each one and reading them thoroughly. I felt rather isolated with my new and evolving view of the subject, and over the next year I gradually connected with other mothers who had similar concerns.

Two of the mothers had had home births and it was actually their midwives who had encouraged them to look into the subject. They both chose to decline any vaccines for their babies. Another

mother, who had been a health journalist prior to becoming a mum, had also investigated the subject before her children were born, and they also remained unvaccinated.

In September 1992, we decided to set up *The Informed Parent* and produce a newsletter to encourage parents to broaden their knowledge on the subject, and allow them to make an informed and independent decision.

We started with just a few subscribers, but within a couple of years we had around 1,800 signed up for the newsletter. Due to the demands of running TiP, the other mothers were unable to continue, and I found myself taking on the newsletter and all the work single-handedly.

I was passionate about getting more information out to the public, and wanted parents to at least be aware that there were, and always had been, great

concerns about the efficacy and safety of this procedure, going right back to its inception and Edward Jenner (who is often referred to as 'the father of immunology').

Although I have managed to keep TiP going for over thirty years, the introduction of the internet had a negative effect on numbers subscribing. Many parents started to turn to social media for their information, and while it is good that there are a lot more articles, videos and podcasts available, it can sometimes be overwhelming and even confusing.

The general feedback I have received over the years from my subscribers is that they find the newsletter a reliable and eye-opening source of information, and also a support.

Of course, all your 15 minute city unitary local authority has to do to reassure and allay the problem is simply to take down the barriers and talk to the communities they purport to be representing... but will they?

Like I said before, I think the best we can all do is to present ourselves. I carry on hopefully in the best way that I can, but I have another question:

# War on humanity disguised as convenience

Terrifying curse of technology - computer age taking over our lives

**THE news that Lloyds, NatWest and other banks are to close more than 80 branches this year comes as no surprise. The drive to internet banking (and with it a cashless society) has resulted in 4,700 branches being shut since 2015.**

Together with Post Office closures, this has transformed the way we handle our financial transactions and our lives. To encourage this, bank apps have been pressed on customers, and branch visits, with their endless queueing, made ever more of a mission.

For us, the client, it becomes about giving in, not having to make the effort, and the gradual appeal - once you grasp the technology - of home banking.

But the thing is, and it strikes me as one of the most important aspects of being alive, that as individuals, we need to make the effort. Without effort, what kind of life do we have; what do we become?

Everyone must agree that labour-saving developments over the years have taken away the drudgery, danger and monotony

of many activities that our ancestors had to bear, and that there have been positive advances through inventive technologies. Where the tipping point occurs, however, is when such advancement ceases to deliver the means for a better quality of life, and instead ushers in an inhuman world where we no longer interact socially, depending on one another for friendship, life-enhancing conversation, working relationships, and the satisfaction of doing a job well and feeling valued.

It is on the elderly and those living alone that the impact of computerised technology and its misguided enforcement is most clearly visible - a brutal shaping of society for the worse. If we ignore the effect on the most vulnerable group in society, we set the seal on a dehumanised world across the board. Our existence will no longer be human in any true sense of the word.

I have an elderly neighbour, a widower, who is beset by loneliness. His visits to the supermarket are about the only social contact he gets. Most of his day is spent in front of his TV, not because he's watching the mind-numbing programmes, but because this box with sound and pictures keeps him company.

We know that loneliness and the psychological effects which stem from it lead to many other ills, both physical and mental - recent research is showing a direct link between loneliness and dementia.

The neighbour's son, who visits him once a week and in many ways is a good son, never tires of telling his dad that modern technology is wonderful. He tries to persuade him to buy a smartphone, and regales him with the benefits of immersing himself in everything that modern advancements have made possible.

"Dad, if only you realise it, you need never have to go to a bank branch again and queue to be served. In fact, you don't really need to be bothered with cash any more, with the risk of being mugged or losing it. You can order all your shopping from your armchair, and have it delivered to your home. You can even have all your meals ordered and delivered, ready to go in the microwave."

What the son abjectly lacks, in his total conversion to the digital age, is empathy; the ability to see things as if you were in the other's shoes. All this harping on from the son is a nightmare to his dad. He loves going to the bank and chatting to people in

the queue. He knows the staff and, in some cases, their families.

His trips to the supermarket are punctuated by meeting other customers, many of whom he knows and those he doesn't, he can get to know just by being friendly. For him, these outings are occasions and a much-needed escape from his isolation at home. It is for them that he gets up and gets dressed.

Doing everything through a computer, with no human involvement, is anathema to him. The son cannot understand why his father does not want to make his life easier. In the place of effort is boredom, isolation, ill-health and a life not being lived at all because of the lack of human contact.

The irony of course is that as the son ages, the same fate faces him when he discovers that his Facebook friends, his Twitter chums and his Instagram followers are no substitute for the warmth, touch and physical contact of real people. By then, of course, he may well have lost the ability to communicate with other humans in any meaningful sense. Computer technology taking over every aspect of our lives could well be hell on Earth, and the isolated elderly are telling us this now.

# Common Law will fail to protect us against tyranny

## Dictators rip up contracts and disregard the law when it suits them

**LIKE** many others who got involved in the wider anti-lockdown movement, I was at first perplexed by what seemed to be the mysterious spread of certain ideas.

These concerned reclaiming our 'true' identity and extricating ourselves from state power by declaration, all of which were presented under the label of 'Common Law'.

It was hard to come to a conclusion on any single aspect of it, let alone evaluate the phenomenon as a whole. But I have since come to my own personal conclusions concerning the validity of many of the specific claims made - a summary of which can be found at Economic Resistance (see link below).

The more I investigated the so-called Common Law approach, the more I came to realise that none of its specific claims really matter, even if some of them are actually true.

This is because the foundation on which the entire approach actually rests is not a matter of historical or legal record, but instead a kind of metaphysical belief about how the universe itself functions.

Here is a quick overview of Common Law that demonstrates how all the points hinge upon this key metaphysical doctrine concerning the importance of contracts:

1. The system of supposed law we all abide by is in fact largely a counterfeit designed to gain our consent to be governed.
2. There is a true system of law which the ruling elite have kept concealed from us in order to be able to gain unfair advantage over us.
3. We unknowingly enter into various

sorts of contract with the ruling powers which allow them to violate our inherent rights due to having first deceptively gained our consent to do so in various ways (i.e., our births being registered, replying to official communications etc.)

4. If we know about the different systems of law and the importance of 'contract' then they, effectively, no longer have any power over us, and we can begin to make demands upon them ourselves.

However, if it was indeed true that the rulers must first trick and confuse those they rule over in order to abuse them in various ways - and this seems to be the basis of the various Common Law theories - then how do its adherents explain the many occasions on which our government and others have resorted to the use of extreme force and other forms of violation against individuals who had clearly not consented to be so treated?

How did the children and adult civilians in various foreign countries 'we' have invaded, or caused to be invaded, enter into a contract with anybody in order

to agree to be blown apart by missiles or starved to death as a result of trade sanctions?

And if they didn't, then how did this occur? Were the politicians not worried about karmically 'breaking the rules' by engaging in this entirely non-contractual behaviour? If not, then why would they care about doing it to us now?

Furthermore, how do political dissidents like Julian Assange and other opponents of the powerful find themselves kidnapped and imprisoned without even the semblance of due procedure or any form of consent? How did the rulers get the victims to consent in any meaningful way to the various forms of abuse uncovered in such atrocities as the Dutroux Affair in Belgium and the recent Epstein scandal in the U.S.? If the elite could engage in these acts without any consequence, or any apparent fear about breaking the rules of reality, then what is stopping them from doing the same to us now, without the need for engaging in complex legal trickery or wordplay whatsoever?

Why does any of this matter anyway? It matters because we all at least claim to

be fighting to uphold our freedoms against a criminal cabal that has given itself the right to dispose of them.

In this struggle, having a faulty, naive or just plain nonsensical model of political and legal reality renders the task, at best, a futile waste of time, and, at worst, a dangerous distraction that plays into the very hands of the authorities it claims to oppose.

In addition, to stand against the system with a false sense of confidence, using incorrect information, can easily lead to people unnecessarily putting themselves directly in the crosshairs of the authorities - a situation which can, ironically, end up giving the system much more leverage and, thus, power over them than it had to begin with.

Although it may be psychologically comforting to convince ourselves that the injustices of the world and the tyranny of the powerful is merely illusory, or something that can easily be 'contracted' out of, the history of recent times shows that the state's power is indeed very real, and that it obeys no laws whatsoever when it feels itself to be threatened in any way, or when its ill-gotten wealth and power are put at risk (see two World Wars, the Communist gulags, state-sponsored terrorism, online censorship laws, etc.)

Not only does this approach waste people's limited time and energy, but it also subtly misdirects them from properly engaging with the reality of the system itself - a reality in which the law is immediately discarded whenever it threatens to actually benefit the non-elite in any meaningful way.

Instead, Common Law leads its followers down a range of esoteric rabbit holes which render them, effectively, useless as far as intelligently opposing the system and its various abuses goes.

For those who do believe in some variety of Common Law solution to the situation we all find ourselves in, I would be keen to hear how they feel that my overall summary of their position is incorrect, and how they would explain the above logical fallacies which, to my mind at least, their beliefs seem to imply.

## Loving and laughing across Britain

### *What have you been up to?*

I spent about five years doing what I do – trying to get people together, to acknowledge how hard things are, but also to give people a reason to be hopeful – in the States, the only place I could still talk.

Nearly a year ago today, Alex Belfield allowed me on the stage in Blackpool – the biggest show they ever had. Commercially it was epic. All of these theatres wanted some of that – 35 booked to have the tour. And then subsequently, Belfield went to prison for five-and-a-half years, and then they pulled 30 of them just because of the systematic, very successful attempt – taking very little effort by the other side, really just down to one individual in particular – lobbying these places into cancelling.

However, it's been totally successful, because of the handful that have held firm – the tickets sold out so fast; because there's a thirst for feeling better, being in a room together, and there is a large underground network of resistance building up in the UK, and so, so many of the venues I do are not theatres or places that can be lobbied. This is an underground speakeasy network. We are in the time of prohibition, so most of what I do, I'll be in the heart of leftist wokedom performing two sell-out nights that were never advertised, and sold out in 24 hours each. When I tell people they're not alone, I really mean it, because this network is vast, connected and it's brilliant.

### *You haven't been on the telescreen for a while?*

Nooo! A lot of producers and talent bookers will approach

me because they know that I'd be great on their show, and I'll always say, 'of course I'd love to do it, but I tell them, just be careful, because when you present this to channel, they'll eat you. It can be very damaging for a young producer to even suggest me for a programme because it can harm how they're seen; I'm always trying to protect people from what can happen being anywhere near my name.

But I am excited because I see the light coming – I see the turn. This has been 20 years for me; 10 years on the road and five years of being utterly eviscerated. I am lucky to have learned a lot of skills.

I suppose now mainstream needs some of my stuff, but they don't know what to do about it. So we had Panorama the other day, they wanted my 15-minute city stuff, they paid me for it but they can't have me on. I gave it away, but they're caught between two stools.

### *You seem to thrive on the adversity?*

I won't stay down, and they know it. I am banned from South Africa, I am banned from Australia for three years, and banned from every single social media platform apart from Instagram and YouTube, weirdly, and I just refuse to stay down. The tide is turning in our favour. This is a really good time to be alive.

I have enormous faith, and I see people want to be included in this network; these are groups that have been built up from freedom movements, not competing with each other, just quietly getting on with it in their towns and cities, and they are immaculate at organising. They can put a message out to their networks, and you can turn up at an underwear shop in

Nantwich with 120 people there. It's desperately exciting.

That's what I'm trying to show people when they're like 'all is lost'. All is not lost, not by a long shot.

### *Do you think socialising is just as important as activism?*

Wherever I go, people are involved with *The Light* paper – they purchase copies to hand them out, and I see that happening, which is glorious. To see 800 people in a theatre relax and turn off the world – not escapism, but remembering how it was and why it still matters, and that you can sit with people who couldn't care less about anything you think, other than wanting you to be alright.

I fundamentally disagree with people who just criticise our side, because when you do that you're facing the wrong direction. But I would argue that there is too much repeating the darkness, talking about the world – lockdown, plandemic, vaccines – yes, but we have to move forward and bring people with enthusiasm and positivity, tapping into the real qualities our side has. It's saying 'look at us endure, look at us prevail'.

Look at Charlotte Wright lose her husband to the vaccine, lose family and friends who told her to shut up, not make a fuss, to not put people off the vaccine, who called her a terrible person, and then end up in court and get his death certificate changed, to call out the vaccine as the cause of death. Look at the NHS 100k - doctors and nurses who said 'no'. That's what I'm trying to do.

### *It's the old British spirit isn't it? We value freedom, and if what you're doing is wrong, we're not going to do it.*

That's why I've been so lucky in having this rebirth right now - people who used to loathe me now come out to see me; i've shown that I won't go down, and we need people who won't stay down, and I'm really happy to be part of that; we need warriors.

### *There's a thing with the truth movement that we don't want leaders. Well we don't want bosses, but we do need people to inspire us, motivate us, light the way...*

To hold the line with us! The audience is the number one priority. That's why it was so heartbreaking with Stafford pulling, letting 500 people down.

Each show, someone becomes the hero of the story. In Blackpool, it was a guy called Phil who laughed so hard, he broke his false leg. The leg fell off, but he wouldn't leave the show, so we went and got some cardboard from the staff and wedged his leg back on and so he stayed. And so the second half became about Phil; we talked about Phil losing his leg, and the whole crowd of 800 people were shouting 'Phil! Phil!' Each show has a hero without planning; they just present themselves. We're made up of many, and it's not about a leader, it's about the heroes that make up the team.

### *Things are changing aren't they?*

I see it all around. Concrete examples like DeSantis in Florida passing the 'let kids be kids' regs, so now you don't have to tell people your pronouns, and women now get their own changing rooms. Corporates are having to strip out all of the woke because of the Bud Light backlash. Blackrock and Vanguard have

stripped out all of that stuff from their annual letter; pulled back on all the climate stuff because they're frightened of alienating ordinary Americans. So the winds of change are upon us – a warning shot for venues.

The more we can get people to feel hope, the more momentum we can gain, because hopeful people are unstoppable. Also, we're coming to summer, a time when people get together and prepare.

### *Are you a Christian?*

My parents and grandparents were Methodist, and I went to a convent school, but obviously I resisted that conformity, but it's the way you live – I would go and help anybody.

There is a lot of proper laughter at my events. My usual bar was that someone has to wet themselves, and that's happened twice, but then Phil's leg fell off so we beat that. But we get a lot of tears as well.

Because lockdown was this mass injury event, like a universal car crash, and I believe people carry that pain every day; they don't talk about it, you don't have an injury to show and talk of, but a lot of tears are still to be had, and that comes out at my events a lot. Allowing people to gather, to believe in something, and have that sense of fellowship with people, without being judged.

People come up all the time and say 'your channel got me through lockdown' – same for Alex Belfield, *The Light* paper – whoever's getting you though, great. People have to heal, and our side are getting people through this, so we've lost a lot fewer people than we would have otherwise lost.

# Crapification of the economy

**INFLATION** is not only evident in the nominal price of everything rising, but also in both the quantity and quality of the goods and services now available to us.

So not only are prices going up - shopping bills have doubled in the past two years, and fuel bills have more than doubled - but the weights and measures we get for the increased amount we pay are also decreasing.

It's more for less - ever decreasing sizes, weights and amounts.

But everything's also becoming worse in terms of quality too. Stainless steel tools that rust, bin bags that split when breathed on, even the fuel we put in our cars has less actual fuel in it and more biofuel, which reduces the lifespan of the engine, leading to more crapification and a race towards the bottom.

At some point, bags won't hold, spanners won't turn, tanks will leak, cables will fray

and everything will become too degraded to use, freezing the economy, but this time permanently.

Instead of raising ourselves up, and the quality of life continually improving for everyone, we have allowed a state of affairs where all of our productivity and creativity, as well as Earth's natural resources, are gobbled up by a money system where a few have control over the economy, and are leveraging that immense power to impoverish the rest of us.

In his OfTwoMinds blog, Charles Hugh Smith writes: "Tossing all the low-quality goods in the landfill and replacing them with even lower quality goods is now the global model of growth.

"But since very few of the discarded goods have recyclable materials that are actually recycled, this waste-is-growth model runs into limits of materials availability and cost - when even low quality becomes too costly, with the bottom 80% of consumers no longer afford to buy replacements.

"As I explain in my recent books, *Self-*

*Reliance in the 21st Century* and *Global Crisis, National Renewal*, once the economies of scale of mass production are lost, production is shut down as it is no longer profitable or viable at lower run-rates and capacity utilisation.

"Which brings us to a projection of what happens on the downside of peak quality - when the system can no longer replace all the low-quality goods dumped in the landfill with equivalent quantities of low-quality replacements at affordable prices. The entire waste-is-growth model collapses.

"The decline in quality reveals that the collapse of the neoliberal-hyper-financialisation-hyper-globalisation model has already occurred. We're simply waiting for the second stage, where it's not just the production of quality goods that collapses: the production of even low-quality goods tumbles off the cliff as economies of scale are no longer enough to keep production profitable.

"The saturation of all demand means sales can only decline, since durable goods last

a long time. The only way to juice sales higher is by making insecure consumers crave the latest fashion, but this artifice has limits.

"The solution was to crapify all products and services via planned obsolescence and endless loops of lousy, over-priced service. Products are now designed to be impossible to repair (eliminating cheapskate do-it-yourselfers) and by using the lowest-quality, lowest-cost components, manufacturers guarantee that the entire product will fail once the lowest-quality component fails.

"And since many components are now digitised, the cheapest electronic component failing will cause the electronics to fail - a £1 chip fails, and the entire £600 product fails - and so the entire product is then destined for the landfill - what correspondent Bart D termed 'The Landfill Economy', a term I now use to describe the entire global economy of planned obsolescence."

## How truth is distorted on TV

**I'VE** been in the TV industry now for close to 20 years.

I was there for the start-up of local TV companies, right through to travelling the world filming sports events. I've worked for major broadcasters including ITV, Sky Sports and the BBC. I have been in and out of newsrooms, been on film sets, and even filmed prime ministers and royalty.

I love my work and I love the medium of film and television.

However, one thing that I've noticed, more so now than ever, is just how easy it is to manipulate and steer an audience. Through a few simple techniques, your opinion may be swayed, influenced or even infiltrated.

This was my motivation to make the documentary *Tell-Lie-Vision*.

Today, people watch television for dozens of hours each week. It could be said that this has been, and still continues to be, one of the most trusted means of communication.

I know from my time in the media that manipulation can be achieved through camera placement, lighting, sound design, colours, effects and graphics. I know, having filmed and edited a variety of productions, consideration is given to everything we see onscreen; from the

smallest of details to the larger set designs and locations.

One thing I highlight early in my documentary is that news and reporting seemed much more thorough and balanced, that programming was more wholesome; with positive messages of family, community and building strong relationships. Now, more so than ever, these traits have faded, with the proof right in front of our eyes.

The documentary also highlights the changing landscape of the media. In the early 1980s, roughly 50 different companies owned 90 per cent of Western media. By 1992, that number had dropped to less than two dozen, and in recent years, that same 90 per cent has fallen to just six major conglomerates. A staggering number considering the reach and influence that is achieved.

With this reach, I often ask myself the question, would we have covid, climate change or the woke agendas, alongside the countless other agendas currently at play, if it was not for our televisions and the power to tell billions of people what to think?

In *Tell-Lie-Vision*, we consider the future of TV, news, and the media industry.



Current trends show a drop in trust by the public. Stats from the Edelman Trust Barometer, Ofcom Communications Market, Reuters Digital News Report and the Broadcasters Audience Research Board (BARB) all show trends demonstrating the falling consumption habits, audience fragmentation and falling trust. Can we take hope in these numbers and figures?

My hope is that we may start to note the many ways in which we all have all been, and continue to be, manipulated on a worldwide scale.

Walter Lippman, author of the book, *Public Opinion*, published in 1922, stated over 100 years ago that people get their information about the world, outside of

their community, through the mass media. He continued to state: "Ours is a problem in which deception has become organised and strong, where truth is poisoned at its source. One in which the skill of the shrewdest brains is devoted to misleading a bewildered people."

# More addictive than cocaine

**Catherine:**

**INSPIRED** by a miraculous, nature-cure healing of a family member, my father trained as a naturopath and osteopath in the 1950s – at the time, a fringe modality. I was the last member of the family to receive a jab of any kind, in my case for polio. There were no western medicines in the house.

My father had an uncanny ability to spot early symptoms and dispatch one to bed on a strict diet of hot water and honey, or fruit. I recall days on end staring at the ceiling waiting to get better. I didn’t like it, but I trusted he knew what he was doing.

There was salad and fruit at every meal, and no desserts. Seven-day fruit fasts for the entire family were routine, and we stayed well away from doctors and hospitals. As a special monthly treat, a single Mars bar was shared out.

Papa’s practice swelled. Clients who’d been written off by the medical establishment experienced astonishing reversals of entrenched conditions. Cutting out sugar was frequently indicated.

I grew up free of sugar addiction, aware that it’s an artificial and addictive stimulant – not a food. I learned that the body tends to heal itself, and it’s my job to support that natural process.

Later, I witnessed friends with heart problems, obesity, energy imbalances and neurological issues. Some underwent radical changes in diet, including cutting out sugar, and got better. My Chinese medicine practitioner taught me more. I read and experimented, and I learned about the longer-term systemic effects of sugar consumption.

I gave up sugar completely in 2010 when I embarked on the 5Rhythms Teacher Training (5RTT). Significant stamina, flexibility, equanimity and strength were called for. I decided to support myself by cutting out sugar, wheat, milk and alcohol.

I was lucky. I already had a healthy lifestyle with hardly any sugar, and a compelling mission – the 5RTT. I was excited, terrified, curious and motivated. It was nice to have something I could feel control over, as I embarked on the rollercoaster ride of the course.

Cutting out sugar has significantly supported me. My physical energy is stronger and more balanced. I have greater equanimity, along with a more delightful mix of vivid emotionality and peacefulness. My thinking is clearer and more agile – all the result of excellent nutrition and no artificial stimulants. Sugar is the most pernicious stimulant there is – highly addictive, ‘pretending’ to provide energy while draining energy and throwing the metabolism off kilter. It never truly satisfies, and leaves us craving ‘just one more hit’. And it’s everywhere. Nasty.

What advice would I offer someone embarking on a sugar-free diet? The way through will be different for everyone, but here are a few principles:

- Assess where you are. For example, are you obese with sugar as a staple; are you healthy with little sugar; are you surrounded by sugar sources; what part does sugar play in your relationships?



- How do you prefer to make changes? Are you an ‘all in’ kind of person; do you do better with gradual, incremental change; are you best handling change by yourself; do you need a group to support you?
- Think about why you’re doing this and ensure that reason is compelling and authentic for you.
- How well informed are you about doing this? If the answer is not very, decide between doing your own research, talking to experts, or joining a support group, etc.
- Set up support. For example, a best friend, a buddy on the same path, a group, or a coach, and contract with them for the duration of the transition.

**Key points to remember:**

- Sugar must be replaced with high-quality, slow-sugar-release nutrition; take away the feeling of starving, and sugar craving goes away.
- The need for comfort is still there when sugar goes away; consciously take care of it, giving yourself what you need and getting help if you need it.
- The enjoyment of socialising over sugar-heavy consumption (alcohol, desserts etc.) is important; create ways to share enjoyable times with loved ones in other ways.

For most of us, giving up sugar is hard. And profoundly empowering.

**Richard:**

**ALAS, I didn’t grow up free of sugar addiction, as Catherine did. We are at very different points in our post-sugar journeys, and she’s helped me greatly on mine.**

As I write, I’ve completely given up sugar for around five weeks now, and my life is already transformed as a result. I’m ten pounds lighter with a body restored to how it was in my 30s; I’m looking years younger, with my hair and skin noticeably healthier; I’ve got a restored, properly functioning system of hunger and satiety; I enjoy energy levels I’ve not experienced for decades (no more ‘spikes’, nor needing to pause when climbing steep hills!); digestion discomfort has completely disappeared; and I’m feeling in complete control of my diet and nutritional choices.

I’m convinced that on any number of wellbeing variables, my health has improved dramatically in just five weeks – and this is just the start! I know all too well that the zealotry of the ‘recently converted’ can be suspect; yet for me, giving up sugar is clearly at least as important for my wellbeing as was giving up smoking (late 1980s) and alcohol (2012).

Sugar is a toxic poison that stimulates the release of neurotransmitters in the brain (dopamine and serotonin), and generates inflammation, mood issues, weight gain and much more. I’m especially interested in the psychology of sugar addiction. There’s a lot of literature on this (see Resources). Yet incredibly, none of the books on the psychology of addiction, per se, mention sugar addiction – despite sugar being found in some studies to be up to eight times more addictive than cocaine!

Catherine is right: giving up sugar is hugely empowering – that’s certainly my own experience. The addicted are necessarily trapped in victimhood; and victimhood is antithetical to the profound personal and spiritual development that surely accompanies blossoming into our full sovereignty and our awakening into truther-consciousness. There will likely be a lot of *The Light* readers hooked on the sugar tyranny. Trust us; perhaps the quickest and most far-reaching contribution you can make to your own wellbeing and healthy longevity is to give up sugar completely. You have absolutely nothing to lose in giving it a go – and everything to gain.



# Getting salty over health

## Body's chemical reactions are giving clues to fighting disease

**WHEN** we think of their health, we are told that too much salt is bad for us. What is 'too much' exactly, and are there any health benefits of a reasonable salt intake?

Table salt, also known as sodium chloride, is consumed the world over in vast quantities. Take Japan, for example, where an individual consumes on average 11.7 grams per day; in the U.S. 9.6 grams and in the UK, 8.6 grams respectively. The recommended salt intake is six grams per day, which is less than what is added to a white loaf of bread; a brown loaf tends to have double that quantity.

Salt has been linked to high blood pressure, known as hypertension, but yet if we look at Japan - where there is an average life expectancy of 85 years - it is ranked way down at 183 in the world for hypertension. The UK and U.S. have significantly higher death rates attributed to hypertension, and so we should question the validity of salt being a cause. Salt is absolutely vital for the body's

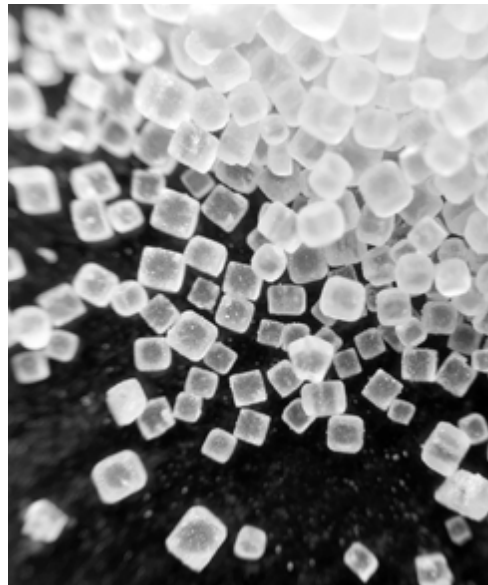

processes. In fact, it is essential for the functioning of our nervous system, for controlling fluid balance, and for our muscles to operate. Excess salt is passed from our bodies by urination and sweating. It is also why we get thirsty when we have eaten something salty.

And then have you noticed that when we cry that our tears are salty? This is due to our bodies having a very similar concentration of salt to that of sea water.

In days gone by, people would go to the seaside to convalesce, and often under their doctor's instruction. This was particularly notable during the 18th and 19th centuries, when a tuberculosis epidemic was engulfing Europe. It was long known that sea air had a healing effect on people, and even more so

with respiratory issues.

So what is it about sea air, and is there any truth to it?

Sea water has roughly the same amount of salt as our bodies. Salt is given off from the surface of the sea and more so in unsettled conditions. Further, salt is responsible for the majority of the clouds in the sky, in that moisture requires salt to be seeded and tiny salt crystals are the perfect host. This is also the main way in which the Earth regulates its temperature, and so we know for sure that salt is in the air.

Interestingly enough, a product produced from salt - hypochlorous acid was utilised massively during covid-19, as a sanitiser for rooms and surfaces.

Although it is a mild bleach, it is considered safe to handle, non-toxic, and extremely cheap to manufacture. It is simply a few grams of salt added to about a litre of distilled water, which then has a small amount of electrical current passed through it (electrolysis).

Hydroxychloroquine contains chloride (chloro) and quinine (quine). Quinine in high doses can cause heart issues, but what of the chloride? The difference with household bleach is that it is hyperchlorite, and so it is important to note that they are both bleaches, but completely different animals.

The next effective treatment I have been hearing about is that of Ivermectin. This product is typically used for treating internal parasite infections. How it functions is to bind with glutamate-gated chloride ion channels which occur

in invertebrate muscle and nerve cells, making them vulnerable to chloride ions.

A chloride ion when reacting with water produces hydrochloric or hypochlorous acid. We have the connection.

The ELVIS study was run out of Edinburgh University, where it proposed the use of salt water in fighting the common cold. The participants were asked to irrigate their nose and gargle the salt water. The results looked positive, although more research was required and subsequent covid trials were to be undertaken. The mechanism here is thought to be that of the body's non-myeloid cells (bone cells) producing, you got it, hypochlorous acid in the presence of sodium chloride.

Our own cells produce bleach to prevent illness and disease. So surely if it works externally, then it must work internally against covid-19 and likely all infections.

My family and I have been boiling a pan of a saturated solution of salt water when cooking dinner since February 2020. We have not had the disease, nor had the vaccine.

There is also evidence that hypochlorous acid is effective against Ebola and then highly likely to be effective against any other latest concern announced by the World Health Organisation.

I am in no doubt that serious research is required here - research that does not put a price tag on human life, where healthcare is hugely affordable and open to all.

And so without salt, we are quite literally a fish out of water.

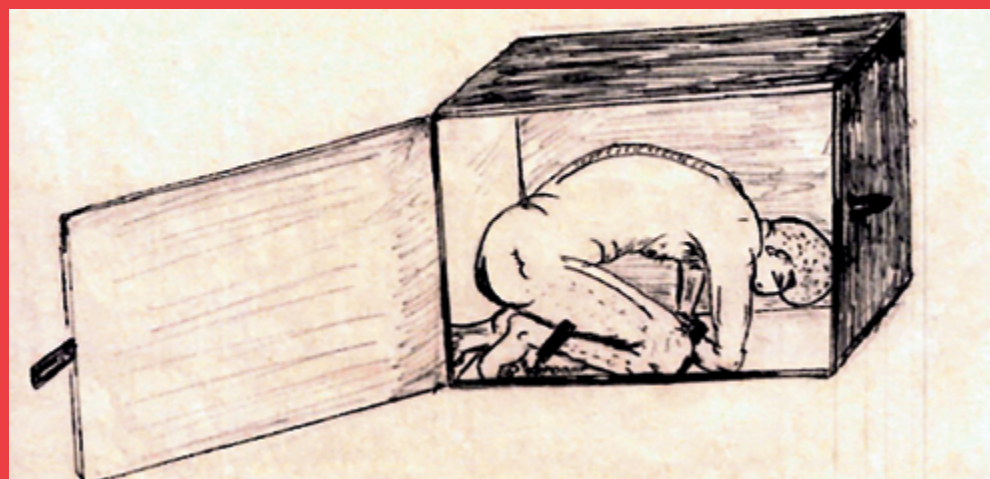


# U.S. still holding ‘forever prisoner’ without charge at Guantánamo



**Drawings by Guantánamo ‘Forever Prisoner’ Abu Zubaydah expose details of U.S. Torture**

**The co-author of a new report featuring the prisoner’s work said that “his drawings are the ultimate repudiation of the failure and abuses of torture.”**

**A REPORT** published last month featuring previously unreleased drawings by Abu Zubaydah, a 52-year-old Saudi who has been imprisoned by the United States for more than 20 years at CIA ‘black sites’ and Guantánamo Bay, offers new insight into alleged torture suffered by a man caught up in a case of mistaken identity.

The report, entitled *American Torturers: FBI and CIA Abuses at Dark Sites and Guantánamo*, is based on sketches and descriptions by Zubaydah and other War on Terror torture victims and was led by Seton Hall University law professor Mark Denbeaux and University of California, San Francisco psychiatry professor Jess Ghannam, with the help of Seton Hall law students.

“Despite the efforts of the federal government, particularly the Central Intelligence Agency, to conceal evidence of the actual operation of the ‘enhanced interrogation techniques’ (EITs) deployed on detainees in dark sites and at Guantánamo, a steady drumbeat of disclosures has provided an unparalleled view into this disgraceful episode in the nation’s history,” the report states.

“Everybody agrees, they tortured the wrong guy; they went ahead anyway so they could get permission to torture other people.”

The report notes that Zubaydah’s drawings “viscerally convey the brutal reality the CIA sought to hide with its calculated destruction of video recordings of torture conducted by its agents,” and “dovetail with the recent accounts of Dr. James Mitchell, a chief architect of the torture regime, who both wrote a book on EITs and testified in

hearings on Guantánamo.

“These sources, together with the report of the Senate Select Committee on Intelligence, provide the most complete—and compelling—account to date of America’s torture program” in the years after the September 11, 2001 attacks on the United States.”

Born in Saudi Arabia, Zubaydah moved to the West Bank in Israeli-occupied Palestine as a teenager. He was captured by CIA, FBI, and Pakistani intelligence agents in Pakistan in late March 2002. Shot in the thigh, testicle, and stomach during the raid that led to his capture, Zubaydah, who was mistaken for a high-ranking al-Qaeda member, was transferred to CIA black sites in Pakistan, Thailand, Afghanistan, Poland, Northern Africa, and Diego Garcia. In September 2006, he was sent to Guantánamo Bay, Cuba, where he remains imprisoned.

Zubaydah was the first so-called “high-value” detainee to be allegedly tortured by U.S. agents, who treated him as a human guinea pig.

“Everybody agrees, they tortured the wrong guy; they went ahead anyway so they could get permission to torture other people,” Denbeaux told the Guardian, which posted the report along with an article by Ed Pilkington on Zubaydah’s experience.

Then-Vice President Dick Cheney, National Security Adviser Condoleezza Rice, and CIA Director George Tenet gave the green light for U.S. agents to torture Zubaydah - even after learning that the prisoner was cooperative. During one discussion on the matter, then-Attorney General John Ashcroft reportedly remarked: “Why are we talking about this in the White House? History will not judge this kindly.”

Zubaydah was subjected to the

interrupted drowning technique known as waterboarding 83 times; rape under the pretext of ‘rectal feeding’; shackling in excruciating stress positions; sleep, sensory and food deprivation; confinement in small boxes; exposure to extreme temperatures and loud music; death threats; beatings and being slammed into walls; sexual and religious humiliation; and other abuses.

Most of the torture techniques approved by the George W. Bush administration - which included waterboarding, deprivation, stress positions, the use of loud music and dogs, slamming into walls, solitary confinement, and exposure to extreme temperatures - are illegal under both domestic and international law.

In addition to these approved EITs, U.S. military and intelligence personnel allegedly subjected terrorism detainees - many of them innocent men, women, and children - to additional abuses, including homicide, rape, imprisonment of relatives as bargaining chips, exposure to sometimes lethally extreme temperatures, and brutal beatings.

“Sexual assault was never approved, nudity was never approved, humiliation by having women present was never approved, and nor was subjecting someone to prolonged torture to the point of exhaustion or worse,” Denbeaux told the Guardian.

“Prisoners died of torture at Asadabad, Bagram, and Gardez in Afghanistan and at Abu Ghraib, Camp Whitehorse, Basra, Mosul, Tikrit, Bucca, and an unidentified facility in Iraq.”

According to a 2005 report by the National Library of Medicine, a federal agency, based on reviews of military documents, 26 War on Terror detainees died as a result of “criminal homicide,” although the paper did not say how many prisoners died on the battlefield

or while in U.S. custody.

“Prisoners died of torture at Asadabad, Bagram, and Gardez in Afghanistan and at Abu Ghraib, Camp Whitehorse, Basra, Mosul, Tikrit, Bucca, and an unidentified facility in Iraq,” the report stated. “These cases do not include deaths due to medical neglect, mortar attacks on prisons, or the shootings of rioting prisoners.”

Zubaydah has never been charged with any crime or tried. He is what’s known as a ‘forever prisoner,’ as the U.S. has no plans to release him.

Last month, the United Nations Working Group on Arbitrary Detention called for Zubaydah’s immediate release while asserting that his continued imprisonment violates the “fundamental rules of international law” and “may constitute crimes against humanity”.

Thirty men remain imprisoned at Guantánamo. Only one has been convicted of a crime. Ten have cases pending before what former military prosecutors have called “rigged” military tribunals, while 16 have been approved or recommended for release.

The administration of President Joe Biden, who has expressed intent to close Guantánamo, has overseen the transfer of a handful of Gitmo prisoners to third countries.

Denbeaux said that: “Abu Zubaydah is the poster child for America’s torture program. He was the first person to be tortured, having been approved by the Department of Justice based on facts that the CIA knew to be false,” Denbeaux noted.

“His drawings are the ultimate repudiation of the failure and abuses of torture.”

**AUSTRALIA'S** cost of living continues to climb, with an almost 10 per cent increase recorded at last quarter. The Reserve Bank has raised interest rates to 3.85 per cent, the 11th increase in 12 months, and energy bills have increased by up to 30 per cent in some states.

There is also an acute housing shortage driving up rental prices, which are going up at a faster rate (11.7 per cent on last year) than general inflation (seven per cent). People who are living on welfare have been hit hardest – a recent survey of 45,895 property listings throughout Australia found only four lodgings that were affordable for a single person on JobSeeker, and these were for rooms in shared houses. It is becoming commonplace to see news stories about families, pensioners and international students forced to live in their cars or in tents for lack of access to housing.

Housing pressure may worsen when Australia welcomes more than 650,000 additional migrants over this financial year and the next under the Federal Government's plan to increase migrant intake by 50 per cent. This will add 900,000 people to the population, which currently sits at just over 26 million. The government has proposed a \$10 billion social housing fund to create 30,000 homes over five years; however, it has not received parliamentary support due to disagreements over the way the fund is structured.

**TAXPAYERS** in Victoria will foot the bill for a whopping \$31.5 billion to pay back borrowings used to fund the state's covid response. Victoria had some of the longest lockdowns and school closures in the world. The Premier, Daniel Andrews, has passed blame to the Reserve Bank, which he says encouraged borrowing and assured Premiers that interest rates would not go up.

Andrews found time to attend drag queen storytime at Parliament House to mark International Day

Against Homophobia, Biphobia and Transphobia (IDAHOBIT) on 17 May. The event was organised by Minister for Equality, Harriet Shing, after a number of storytime events at local libraries were cancelled due to community pushback or safety concerns. Shing said, "We will never, ever let a small, hate-filled rabble take away from our joy, our pride, our dignity and our wellbeing."

**AGE** verification for adult websites may involve government-issued digital ID.

Stakeholders agree on the necessity of safeguarding minors from accessing pornography sites, but are divided on the proposed use of digital ID, particularly in light of several recent data breaches affecting Optus and Medibank customers. The Australian government allocated over \$26.9 million to the digital ID project in the most recent budget.

**Pfizer** has weighed in on an upcoming referendum in which Australians will vote on whether to change their constitution.

Pfizer has pledged its support for the YES vote, which would see the establishment of an Indigenous Voice to Parliament advisory body. Since Pfizer's rebrand as a quasi-humanitarian organisation during the covid pandemic, the company has repositioned itself as an 'ally' of marginalised minority groups, creating opportunities to 'listen to the stories and lived experiences' of Australian First Nations people. The Pfizer vaccine-injured can only

dream of the pharmaceutical giant listening with such commitment to their lived experiences.

**THE** Australian Capital Territory (ACT) has banned new gas connections in home and business builds in its effort to phase out fossil fuels by 2045.

The ACT Government is committed to all-electric buildings powered by renewables.

**IN** Western Australia (WA), a series of police raids on journalists and activists has raised concerns about press freedom in the state.

The targeted persons are associated with climate activism to disrupt Woodside's gas project at the Burrup Hub, during which the company will move and likely damage Aboriginal rock art. At least two journalists and two activists have reported harassment, unreasonable confiscation of work equipment, denial of fair procedure, and intimidation from WA police within the past month, a pattern of behaviour that targeted journalist Jesse Noakes characterised as 'pre-emptive policing.'

**ALSO** in WA, a mother lost parental rights after requesting a second opinion for her 6-year-old son's leukaemia diagnosis before consenting to the hospital's recommended treatment plan.

The hospital called Child Protection, who put the child into foster care. The boy was started

on chemotherapy within the week, without the mother's consent. The mother and son cannot be named as it would be considered a breach of the conditions of foster care.

**ALMOST** a dozen schools in New South Wales (NSW) have transitioned back to remote learning in response to an alleged new covid outbreak, with one school reinstating a temporary mask mandate.

A spokesperson from NSW Department of Education confirmed that teacher shortages due to illness are also a factor in moving students to at-home learning.

**95-year-old** grandmother Clare Nowland, from NSW, is in a critical condition after being tasered by police as she approached them with a steak knife and a walker in her nursing home.

Nowland has dementia and was reportedly moving at a slow pace when the policeman, who was struggling to disarm her, employed the taser. NSW Police have not confirmed whether the police officer has been formally stood down, but he is 'no longer in the office'.

**NEW** Zealand has recorded its largest increase in excess deaths since the 1918 influenza pandemic.

For the year ending December 2022, there were 38,574 deaths, with 3,642 more deaths than the previous year (2021), an increase of 10.4 per cent. Government sources cite covid and an ageing population as the cause of the increase in mortality figures. 2,400 New Zealanders died with covid in 2022, accounting for two thirds of the total excess deaths. Fact checkers report that a popular conspiracy theory that covid vaccines are causing 2022 excess deaths is false, because most New Zealanders were vaccinated in 2021. Fact checkers omit that third and fourth doses were administered to New Zealanders throughout 2022.

# Covid injections a ‘military project’

## Pfizer claims products were Department of Defense prototypes

**THE pharmaceutical industry’s main role in the ‘pandemic’ project has been to provide cover for what is a military bioterrorism programme, it has been claimed.**

Sasha Latypova is a former pharmaceutical research and development executive who has supervised more than sixty clinical trials of new drugs for the industry, and understands every step of the regulatory protocols which govern bona fide studies and trials.

In early 2021, however, she observed that the strong safety surveillance signals of the new injectables being registered in the U.S. Vaccine Adverse Events Reporting System (VAERS) were not triggering the automatic stop and recall mechanism, and the relevant regulatory bodies were showing no concern.

This led her to conclude that there was malicious intent.

From then on, she set about examining minutely every aspect of the development, procurement and manufacturing processes of the ‘vaccines’ being rolled out en masse, through Freedom of Information (FOI) requests.

To illustrate her point, she explains that in January of 2021, an unusual number of allergic reactions were flagged up in California, following administration of the Moderna product. In any normal safety surveillance system, lots are tracked by their numbers, and if a clustering of problems or deaths occurs with certain batches, these are immediately recalled for analysis. This is automatic and is done by the manufacturers, in the same way as for car parts or food products.

Instead, in this instance, the lots in question were simply distributed more widely, causing sixty-five deaths and three thousand serious adverse events. Latypova explains that once a safety signal is flagged up and no recall action is forthcoming, law enforcement is normally triggered and prosecution of those responsible follows.

She emphasises, however, that we are not dealing with straightforward pharmaceutical corruption. The fraud which confronts us is all-encompassing, because at its centre is the government, through the Department of Defense (DoD), with the complicity of the pharmaceutical industry. The pharmaceutical industry’s main role in the project has been to provide cover for what is a military bioterrorism programme. They went through the motions of conducting animal studies and clinical trials of the ‘covid-19 vaccines’, and of submitting applications for drug approval to the corresponding regulators in each jurisdiction.

All this was entirely for the benefit of the public, because regulators of medicines and medical devices have no authority over the distribution of these injectibles, which are classed as military ‘counter-measures’. They are passed off as pharmaceutical vaccines because no-one would take a substance from a vial with a DoD label marked ‘prototype’. According to Latypova, they are

also described in government documents as dual-use (military and civilian) biological weapons. Latypova explains that the entire logistical operation of development, procurement, production and distribution is run by the U.S. DoD. They farm out the manufacturing to hundreds of separate military contractors all over the world, and there are dozens of production steps, each implemented by a facility that fulfils a single process in the chain.

Substances are shipped internationally from one place to another where workers have no idea what the materials they receive contain. They are simply instructed to mix them and ship the product on to the next location. So the normal requisites of quality control procedures which take place at a plant at the various stages of production, to test for contaminants and ensure consistency, as well as the inspections to certify good manufacturing practices, are completely absent. Largely inexperienced operatives,

untrained in the proper procedures for the manufacture of pharmaceutical products pose little threat of whistle-blowing. It is a compartmentalised operation under military control. The result is billions of vials of biological materials of unknown composition all over the world. Some may be blanks; some may be extremely toxic.

Once we correct the false assumption that the injectables are pharmaceuticals regulated by the U.S. Food and Drug Administration (FDA), and by the corresponding regulators of health products in other countries, some pieces of the puzzle start falling into place. We cease wondering why the ‘safe and effective’ mantra is robotically repeated by those supposedly responsible for regulating and monitoring drug safety, in the face of overwhelming evidence of harm. It is because the approval process was a sham and the regulators have no power over the product.

European Medicines Agency (EMA) email communications examined by Latypova revealed that their reviewers raised 140 objections against Conditional Marketing Approval. She explains that ten to fifteen objections would ordinarily be sufficient to halt an approval. Notwithstanding, a fortnight later, the products were shipped internationally, breaking every rule.

On the one hand, the injectables are being sold to the public as ‘health products’, while in fact being placed in a completely different category, referred to in the documentation as ‘prototypes’ or ‘counter-measures’.

The mechanism allows the Pentagon to hide whatever it is doing in total secrecy and avoid any federal accounting rules. This is significant because the DoD has an annual budget in excess of \$800 billion, enabling it to extend its tentacles around the world in ‘black box’ conditions - untraceable and unaccountable. Latypova has teamed up with legal researcher Katherine Watt to share her documented evidence, as has Brook Jackson who brought

a case in January 2021 against Pfizer and others under the False Claims Act, for falsifying statements and manipulating data, in breach of their own protocol and federal regulations. Pfizer, in April 2022, moved to have the case dismissed on the basis the products were not vaccines but DoD prototypes, and they were never obligated to prove safety or efficacy. In October 2022, the U.S. government filed a statement of interest in support of Pfizer’s motion to dismiss, thus endorsing this characterisation.

Katherine Watt is working to assemble the package of evidence of manufacturing and distribution crimes perpetrated by the military, and clinical-trial fraud crimes perpetrated by Pfizer, to build cases through the few remaining channels of civil access points.

From the civil cases, she hopes to create a bridge to criminal cases based on laws prohibiting chemical and bioterrorism, with the ultimate aim of progressing to treason charges against the members of Congress, Presidents and Cabinet Secretaries responsible for enabling the illegitimate moves which have led to what Latypova describes as: ‘the best documented atrocity, as far as deaths and injuries are concerned, in human history.’

# International news roundup

## LLOYD'S becomes latest firm to exit UN's net-zero alliance

Insurance company Lloyd's of London has announced its exit from a net-zero alliance for insurers - the sixth such organisation to have pulled out from the initiative within a week. The Net-Zero Insurance Alliance (NZIA), convened by the United Nations, seeks to commit group members, composed of the world's leading insurers and reinsurers, to fighting supposed climate change.

As part of this, members have to transition their insurance and reinsurance underwriting portfolios to net-zero greenhouse gas (GHG) emissions by 2050. Lloyd's of London's exit took the total number of members who have quit the NZIA in one week to six, which represents a fifth of the organisation's total of 30 members. Since March, a total of 10 members have quit the NZIA. The insurance firms are said to have decided to pull out due to concerns about getting embroiled in disputes about net-zero initiatives in the United States. On May 15, attorneys general from 23 American states sent a letter to 28 insurance companies asking for information about potential violations of antitrust laws.

## BLACK Lives Matter heading for bankruptcy as insiders pocket millions

Black Lives Matter finished its latest fiscal year nearly \$9 million in the red, even as the organisation continued shelling out millions to executives and relatives of co-founder Patrisse Cullors, according to new tax documents posted last month and first reported by the *Washington Free Beacon*.

The Black Lives Matter Global Network Foundation spent double what it took in – \$17 million in outlays, against just \$8.5 million in gross revenue. In contrast, the group took in a whopping \$77 million in contributions and grants in the preceding fiscal year, which included half of 2020. Assets plummeted by 28%

year-over-year, from \$41.9 million to \$30.2 million for the fiscal year.

“That means it has spent two-thirds of the \$90 million it raised [in 2020],” reports the *New York Post*. Given this report is for the fiscal year that ended on June 30, 2022, the group's balance sheet may look a lot worse today, after another 11 months of potential deterioration.

## INDIA continues war on cash

The Indian central bank has announced another round of demonetisation with a plan to withdraw 2,000-rupee notes from circulation.

The 2,000-rupee note will remain legal tender, but they will have to be deposited or exchanged for smaller denominations by September 30. It is the largest currency denomination in India. According to Reuters, the notes make up about 10.8% of the currency in circulation.

T.V Somanathan, the top official at the Indian Finance Ministry, said confiscation of the 2,000-rupee notes wouldn't cause any disruptions “either in normal life or in the economy.” His assurances fall flat given history.

The Indian government announced a surprise demonetisation policy in the autumn of 2016, and declared that all of the 1,000 and 500-rupee notes then in circulation would no longer be valid. The suddenly-worthless notes made up 86% of the currency in circulation in the country at the time. The move made virtually all of the cash in India valueless.

The government produced new 500 and 2,000-rupee notes to replace the old currency, and now the government is pulling those 2,000-rupee notes out of circulation.

The idea was to push Indians into putting their hoarded cash in the bank – thus bringing it ‘out of the shadows’. The policy resulted in severe cash shortages, with as many as 90% of ATMs in some regions of the country completely

running out of currency.

The Indian government's move is part of the broader war on cash. The vast majority of transactions in India are in cash. It is an overwhelmingly cash economy and virtually every Indian has currency stashed away in their home.

The war on cash isn't confined to India. The European Central Bank stopped producing and issuing 500-euro notes in 2018, and officials in the U.S. have floated the idea of eliminating the \$100 bill.

More recently, governments are slowly introducing central bank digital currency (CBDC) as a cash replacement.

## FACIAL recognition for ATMs coming to Japan

Seven Bank, a leading banking institution in Japan, has announced its intention to pioneer the nation's first-ever facial recognition service for ATMs, according to a statement by President Masaaki Matsushashi to Nikkei.

The service will launch in March 2024, enabling customers to make cash deposits and withdrawals across approximately 20,000 ATMs, without the need for customers to present their cash cards.

Most of the 25,000 Seven Bank ATMs, which are conveniently located in Seven-Eleven stores across the country, will be equipped to facilitate facial recognition.

Account holders will receive a unique ID mandatory for all future transactions as an additional security measure.

## UKRAINE sending untrained recruits into battle

Ukraine sent untrained recruits into the battle of Bakhmut to save its professional soldiers for an expected counteroffensive, *The Wall Street Journal* reported.

The paper spoke with men who were part of a small group that was sent into Bakhmut, which

became known as the meat grinder, just a few days after being mobilised. Out of 16 men in the group of draftees, 11 were either killed or captured. The *Journal* described them as “mostly poor men from villages in the northeastern Kharkiv region, many of them unemployed, doing odd jobs as handymen or shift work at factories in the regional capital.”

Some of the men had military training years or decades ago, but none had combat experience. A few of them threatened to refuse orders when they were told they were being sent to the frontlines on February 21, citing a lack of training, but they ultimately went. One man, Vladyslav Yudin, told the *Journal* that he told a sergeant major that he had never fired or even held a gun before. “Bakhmut will teach you,” Yudin was told.

The *WSJ* explained the reasons for such Somme-like tactics:

‘In an effort to preserve brigades trained and equipped by the West for a widely anticipated offensive, and with many of its professional soldiers dead, Kyiv sent in mobilised soldiers and territorial defence units, sometimes with patchy training and equipment. The ultimate success or failure of Ukraine's strategy in Bakhmut will hinge on the results of the bigger offensive.

“If you can avoid having to divert your decisive combat force toward something like Bakhmut, which would have a long-term negative impact on the overall counteroffensive, then you do it,” said retired Lt. Gen. Ben Hodges, a former commander of the U.S. Army in Europe. “Of course you still pay a high price.”

## WEST has spent \$65 billion on war in Ukraine

The Ukraine Defense Contact Group, based at Ramstein Air Base, Germany, is an alliance of 54 countries supporting Ukraine militarily against Russia.

In a new press briefing marking the 12th meeting of the group, U.S. Defense Secretary Lloyd Austin revealed the total tally of

funds and military aid pumped into Kiev. “In total, the Contact Group has committed nearly \$65 billion in security assistance,” while stressing the Western allies are “as united as ever.” This total figure is separate from the Washington overall commitment as far as Ukraine aid goes, which is even larger.

This already huge figure is about to leap significantly higher, given that Austin said: “President Biden announced that the United States will support a joint effort with our allies and partners to train Ukrainian pilots on fourth-generation aircraft, including F-16s. We hope this training will begin in the coming weeks.”

The Pentagon chief then thanked Denmark and the Netherlands for stepping up to lead the European coalition. The programme is expected to take multiple months to up to a year or more.

“In the coming weeks, my Dutch and Danish counterparts will work with the United States and other allies to develop a training framework,” Austin said. “Norway, Belgium, Portugal and Poland have already offered to contribute to training, and we expect more countries to join this important initiative soon.”

Austin further emphasised that the United States is “committed to standing with Ukraine for the long haul.” He also announced a new commitment to provide Kiev with “additional air-defense systems and munitions” which will be “crucial” for “protecting Ukraine's skies and civilian infrastructure from Russia's assault.”

# Cancer – it's not what we're told

## Part Two of an analysis of the Big C and its many causes

**MODERN medicine is widely acclaimed as being the best and most advanced scientific form of healthcare.**

Yet it has failed to reduce the incidence of some of the most deadly diseases that ravage the human race. As shown in Part One in last month's Light paper, the incidence of cancer is continuing to increase.

And it remains one of the leading causes of death worldwide.

Cancer increasingly affects young people, a fact that poses a serious and fundamental challenge to the notion that it is a disease of ageing.

An October 2022 article in the journal *Nature* entitled *Is early-onset cancer an emerging global epidemic? Current evidence and future implications* says current evidence and future implications attempt to explain possible reasons for the increase in early-onset cancers.

It reads: "Trends have emerged towards increasing height, overweight and obesity, type 2 diabetes, physical inactivity, western-style diet (defined as a diet high in saturated fats, red meat, processed meat, sugar and ultra-processed foods, but low in fruits, vegetables, whole grains and fibre) and sugar-sweetened beverage intake in children, adolescents and adults worldwide."

Whilst some, but not all, of these factors may contribute to poor health, they are not the only ones that need to be considered with respect to the onset of cancer. Interestingly, although possibly unsurprisingly, a search within this 18-page journal article did not produce a single result for the word 'chemical' nor for the word 'toxin'.

Chapter 6 of our book, *What Really Makes You Ill*, details many of the toxic chemicals to which we may be exposed throughout our lives. It is not our intention to scare but to inform people to enable them to make informed decisions.

On the list of known and probable carcinogens on the American Cancer Society website are the following: arsenic, benzene, cadmium, formaldehyde and trichloroethylene.

The main point to emphasise is that neither the World Health Organisation fact sheet on cancer nor the *Nature* article refers to the long list of known chemical carcinogens that can be found on the ACS website.

It is obvious that the chemical industry has a vested interest in keeping the public ill-informed about some of the very real causal factors of their health problems.

The inclusion of formaldehyde alone on the list of known carcinogens is noteworthy in the context of the increased incidence of cancers in young people. Although correlation is not proof of

may not appear as cancers until many decades later and recognises that certain 'medicines' are associated with cancer, saying: "Antibiotic use, which has been associated with certain cancer types, has increased in both adults and children in many countries over the past half century."

Furthermore, a 2008 news article published in the *Lancet* entitled, *A Review of Human Carcinogens - Part A: Pharmaceuticals* refers to a meeting at the IARC (International Agency for Research on Cancer) in which 21 scientists reaffirmed the

*population exposure to carcinogens from chemotherapy*. The article states: "Over 20 cancer chemotherapy drugs, including widely used drugs such as cyclophosphamide, doxorubicin, 5-FU and etoposide, cause patients receiving them to excrete known human carcinogens in vomit, sweat, urine or faeces."

Yet the WHO fact sheet claims that "cancer mortality is reduced when cases are detected and treated early."

The evidence that many of the drugs that are widely used as chemotherapy treatment are known to be carcinogenic would suggest otherwise.

It is also important to emphasise that some methods used to test for the presence of cancer are also known to be carcinogenic - X-rays, for example.

What is particularly noteworthy, yet rarely discussed, is the actual procedure used for determining if a biopsy sample is 'cancerous' or not.

A video entitled *From biopsy to diagnosis*, uploaded in January 2020 to the Michigan Medicine YouTube channel, describes the process as follows: "This behind-the-scenes look into the University of Michigan Department of Pathology shows how tissue is prepared to be viewed under a microscope and what pathologists are looking for in order to determine a diagnosis."

The process for assessing the biopsy material is rather technical and involves the use of a variety of chemicals and procedures. One chemical is formalin, which is used in the first step of the procedure known as fixation, that is claimed to ensure preservation of the tissue.

It should be noted that formalin is a solution of formaldehyde; a recognised Group 1 carcinogen. This step is followed by other procedures that include dyeing, and dehydration with alcohol. The alcohol is then removed by a chemical known as xylene, which is recognised as being toxic.

It is assumed, however, that none of these chemicals and procedures has an effect on the sample being tested. But this is a mistaken assumption, as has been demonstrated by the work of Dr Harold Hillman PhD, a cell biologist, who states in his 2013 paper *A Serious Indictment of Modern Cell Biology and Neurobiology* that: "Biologists have shown little interest in the effects that the procedures they use have on the structure and chemistry of the tissues they are studying."

**3 GMOS**

**4 Government food regulation authorities use animal testing to approve fake meat**

New GMO ingredients can be tested by Government food regulations on animals, to then be approved for human consumption.

Impossible Burger’s scientists fed the leghemoglobin (GMO fake blood) to rats for 28 days to determine the risk of allergic reaction or toxicity.

**5 Dismantle our connection with nature**

Fake meat ignores man’s connection with nature, and ignores indigenous people, local farmers and years of ancestral knowledge.

“These artificial, synthetic foods dismantle our connection with nature and in doing so, disregard the role of natural processes and the laws of ecology that are at the heart of real food production.” - Vandava Sheeva.

**6 Toxic levels of glyphosate**

Industrial agriculture is one of the most unsustainable practices today. The ‘bigger is better’ food system has reached a point where its real costs have become readily apparent.

Toxic high levels of Glyphosate have been found in fake meat. Glyphosate not only contributes to the rising number of people who suffer from health conditions - diabetes, heart disease, respiratory issues and obesity, but is one of the main reasons the Earth’s cycles have ruptured, causing biodiversity loss, soil desertification and mass water pollution.
